MORTGAGE OF REAL ESTATE

COUNTY OF GREENVILLE

To All Whom These Presents May Concern:

We, Louise C. Simmons and Minnie M. Owens, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Five Thousand, Six Hundred and No/100----- (\$ 5,600.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of Fifty and 34/100----- (\$ 50.34) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 15 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the southern side of Easley Bridge Road being known and designated as Lot No. 4 of Block 7 on plat of property of Judson Mills recorded in the R. M. C. Office for Greenville County in Plat Book X at Page 143, and being more particularly described by metes and bounds as follows:

BEGINNING at an iron pin on the southern side of Easley Bridge Road at the joint front corner of Lots 4 and 5 and running thence with the line of Lot 5, S. 43-20 E. 106 feet to pin in line of Lot 3; thence with the line of Lot 3, S. 0-23 E. 29.9 feet to pin on C Street; thence with the northern side of said street, the following courses and distances: N. 89-67 W. 46.5 feet; N. 61-16 W. 46.9 feet; N. 36-08 W. 50 feet; thence with the curve of the intersection of C Street and Easley Bridge Road, N. 4-36 E. 15.1 feet to pin on Easley Bridge Road; thence with the southern side of Easley Bridge Road, N. 45-15 E. 52.3 feet to the point of beginning; being the same conveyed to us by Leon Moody by deed of even date, to be recorded herewith.
