## MORTGAGE OF REAL ESTATE

of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his  
account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly  
paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted,  
bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and  
being in the State of South Carolina, County of Greenville on the Eastern side of West Dorchester Boulevard,  
near the City of Greenville, being shown as Lot No. 126 on a plat of Belle Meade, recorded in  
Plat Book EE at Page 117 and described as follows:BEGINNING at a stake on the eastern side of West Dorchester Boulevard 170 feet south  
from Camden Lane at the corner of Lot No. 127, and running thence with the eastern side  
of said Boulevard S. 35-05 E. 70 feet to a stake, corner of Lot No. 125; thence with the  
line of said lot N. 56-53 E. 194.4 feet to a stake; thence N. 28-13 W. 80.2 feet to a  
stake at the corner of Lot No. 127; thence with the line of said lot, S. 54-05 W. 204

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right  
and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances  
except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the
