WHEREAS: JASPER E. DAVIS AND SUE B. DAVIS

Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

Collateral Investment Company, a corporation

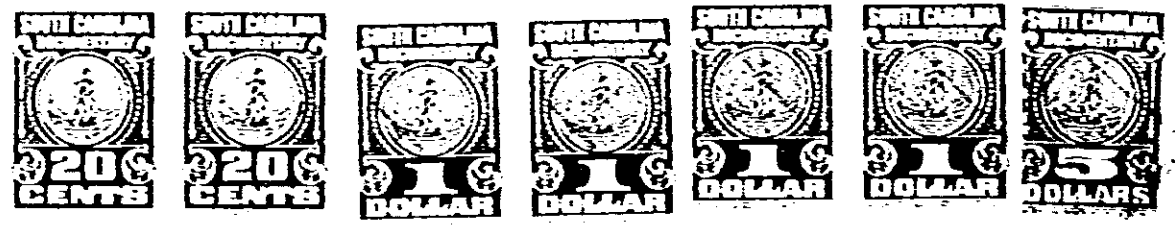
organized and existing under the laws of Alabama, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-Three Thousand Five Hundred and No/100-----Dollars (\$23,500.00-----), with interest from date at the rate of eight and one-half----- per centum (8 1/2 %) per annum until paid, said principal and interest being payable at the office of Collateral Investment Company in Birmingham, Alabama, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Eighty and 72/100-----Dollars (\$180.72-----), commencing on the first day of March, 1974, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 2004.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, at the intersection of Vicksburg Drive and Dinwiddle Drive, being shown and designated as Lot No. 18, on plat of Section 4, Richmond Hills, recorded in the RMC Office for Greenville County, S. C., in Plat Book "JJJ", at Page 81.

Included as a portion of the mortgaged premises is the following easily removable item:

Wall-to-wall carpet in living room, two (2) bedrooms, and den.
