### MORTGAGE

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Academy Rentals, a Partnership ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-one Thousand One Hundred Thirty-five and 56/100 -----

DOLLARS (\$ 21,135.56 -----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being

ALL that piece, parcel or lot of land situate, lying and being on the eastern side of Old Buncombe Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 72-A of a re-subdivision of Lot No. 72, of a subdivision known as Cedar Vale, plat of said re-subdivision of Lot No. 72 is recorded in the R.M.C.
