NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor reay be indebted to the Mortgagor it any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars 53.60 to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt who reof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, the Mortgagoe's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the northeast side of Longview Terrace, and being shown as all of Lot No. 43 on plat of Forest Heights, which plat is recorded in the RMC Office for Greenville County, S. C. in Plat Book P at page 71, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeast side of Longview Terrace, at the joint front corner of Lots 43-A and 43, and which point is 952 feet southeast of the intersection of Longview Terrace with East Faris Road; thence along line of Lot 43-A N. 48-04 E. 121.8 feet to an iron pin; thence S. 30-20 E. 90 feet to an iron pin at rear corner of Lot 42; thence with the line of Lot 42, S. 54-42 W. 114.5 feet to an iron pin on the northeast side of Longview Terrace; thence with the northeast side of said street, N. 35-18 W. 75 feet to the point of beginning.
