All that certain piece, parcel or lot of land, situate, lying and being on the eastern side of Davis Drive in Greenville Township, Greenville County, State of South Carolina, being shown and designated as Property of Mayo C. Rose on a plat thereof by Carolina Engineering & Surveying Co. dated June 21, 1965, recorded in the RMC Office for Greenville County, S. C. in Plat Book KKK, at Page 25, and having 1.32 acres.

ALSO:

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the eastern side of Davis Drive and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Davis Drive, the joint front corner of the property of Talmer Cordell and a lot recently conveyed to Clarence E. Shockley, and running thence along the Shockley line S. 63-58 E. 200 feet to an iron pin; thence on a line parallel with Davis Drive S. 14-04 W. 150 feet to an iron pin; thence N. 63-58 W. 200 feet to an iron pin on the eastern side of Davis Drive; thence along the eastern side of Davis Drive N. 14-04 E. 150 feet to an iron pin;

Together with all and singular rights, members, berditaments, and appurtements to the same oelonging in any way incident or appertaining, and all heating, plumbing, and lighting fixtures now or hereafter of all the rents, issues, and profits which may arise or be had therefrom, attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgages forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also the payment of taxes, insurance premiums, public assessments, repairs of other purposes pursuant to the covenants netern. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premises therefor when due, and that it does hereby assign to the Mortgagee the proceeds of any policy increase the mortgaged premises and does all premises the proceeds of any policy increase the mortgaged premises and does all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
