All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot No. 3 in accordance with Plat made by C. C. Jones, dated March 23, 1956, entitled "Property of S. M. Forrester" recorded in the R.M.C. Office for Greenville County in Plat Book ZZ, Page 75, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Sunrise Drive, joint front corner with Lots 2 and 3 and being 187.3 ft. from the intersection of Sunrise Drive and Hyde Circle and running thence along Lot No. 2, S. 24-30 E., 151.4 ft. to an iron pin; thence S. 75-45 W., 90 ft. to an iron pin; thence N. 24-15 W., 155.2 ft. to an iron pin; thence N. 78-18 E., 90 ft. to an iron pin being the point of beginning.


