NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 69 on a plat of Buxton, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 4N-3, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Wallingford Road, joint front corner of Lots 69 & 70 and running thence with Wallingford Road S. 35-59 W. 25 feet to an iron pin; thence S. 31-00 W. 135 feet to an iron pin; thence N. 74-12 E. 34.15 feet to an iron pin; thence N. 58-51 W. 72.1 feet to an iron pin; thence N. 54-26 W. 32.9 feet to an iron pin, at the joint front corner of Lots 68 & 69; thence the with line of Lot 68 N. 31-42 E. 161.6 feet to an iron pin; thence with the line of Lot 70 S. 68-12 E. 130 feet to the point of beginning.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
