

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the westerly side of Bates View Drive (formerly Bates Drive, in the City of Greenville, South Carolina, and being shown as Lot No. 6 on/of Northside Gardens as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S, page 17, and having according to said plat the following metes and bounds, to-wit:
