"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city of Greenville, on the northerly side of Queen Ann Road, known and designated as Lot No. 48 on plat entitled "Final Plat Revised, Map No. 2, Foxcroft Section II" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4N, pages 36 and 37 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northerly side of Queen Ann Road, said pin being the joint front corner of Lots 47 and 48 and running thence along the common line of said lots N. 23-33 W. 258.1 feet to an iron pin, the joint rear corner of Lots 47 and 48; thence S. 89-29 W. 52 feet to an iron pin, the joint rear corner of Lots 48 and 49; thence with the common line of said lots S. 3-38 E. 267 feet to an iron pin on the northerly side of Queen Ann Road; thence with the northerly side of Queen Ann Road N. 82-36 E. 71 feet to an iron pin; thence continuing with said road N. 72-38 E. 71 feet to an iron pin, the point of beginning.
