14. That in the event this mortgage should be foreclosed, the Morteazor expressly makes the benefits of Sections 45-88 through 45-961 of the 1962 Code of Laws of South Carolina as amended, or any other appraisement Laws

## THE MORTGAGEE COVENANTS AND AGREES AS FOLLOWS:

- 1.
