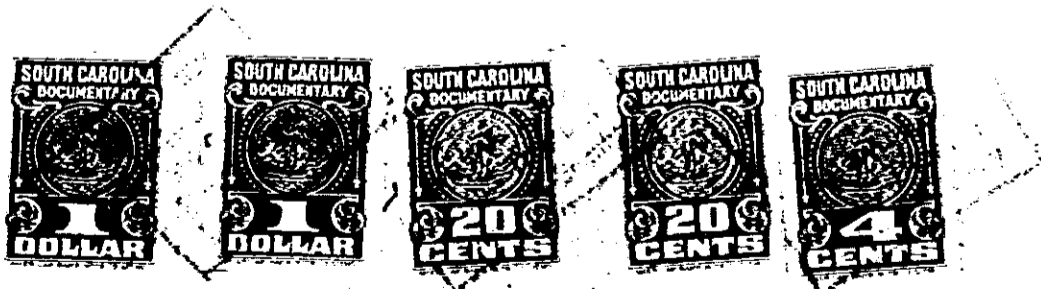
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being part of Lot No. 31 as shown on plat of University Heights recorded in the RMC Office for Greenville County in Plat Book Y at page 53, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the northern side of Midland Street at the joint front corner of Lots 33 and 31; thence with rear line of Lots 33 and 32, northwest 203 feet to an iron pin in line of Lot No. 32; thence a new line through Lot 31, northeast 110 feet, more or less, to an iron pin in the line of Lot 31, rear corner of Lots 19 and 30; thence with line of Lot No. 30, S 31-20 E 203 feet to an iron pin on the northern side of Midland Street; thence with the northern side of Midland Street, S 68-30 W 100 feet to an iron pin; thence continuing along the northern side of Midland Street, S 69-30 W 46 feet, more or less, to the point of beginning.

This mortgage is junior in lien to the mortgage given by the mortgagors to Carolina Federal Savings & Loan Association in the amount of \$26,400.00 given on even date herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
