"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, known and designated as all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina lying on the northern side of Lavinia Avenye and known as Lot 32 in Greenville County Tax Map \$40, block 2, and having according to plat made by R. B. Bruce, R.L.S. of Carolina Surveying Company, March 29, 1974, the following metes and bounds:

Beginning at an iron pin on the Northeastern side of Lavinia Avenue and running thence with the Northeastern side of Lavinia Avenue 21-45 W 60 feet to a pin; thence N 73-45 E 155 feet to a pin on a 10 foot alley; thence with the 10 foot alley S 21-45 E 60 feet to an iron pin; thence S 73-45 W 155 feet to the point of beginning.
