WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, shown as Lot No. 131, on plat of Holly Springs, Section II, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 4R, at Page 54, and having, according to said plat, the following metes and bounds, to-wit:
