It is hereby agreed, that should any default be rade in the jayment of interest on eaid first mortage, and such interest remains unpaid and in arrears for ten days, or should any suit be commence! to foreclose said first nortgage, then the amount secure! by this mortgage and the accompanying note shall become and be due and payable at any time thereafter at the potion of the owner or holder of this mortgare.
