## MORTGAGE

To All Whom These Presents May Concern: I, James Wilson Greer,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

- - - - ONE THOUSAND SEVEN HUNDRED AND NO /10 DOLLARS (\$1,700.00), with interest thereon from date at the rate of eight and one-half-per centum per annum, and principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars \$3.00, to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near St. Mary's S. C. Methodist Church, lying on the west side of the St. Mary Road, being bounded on the north by property of St. Mary Church and Lot No. 11, on the east by St. C. Church property and the said St. Mary Road, on the south by Lot No. 10, and on the west by Lot No. 11, and being shown as Lot No. 10 in plan of property of J. L. Greer Estate, said plan made by J. L. Greer Esq. in 1881, 1/8, and bearing the following courses and distances, to wit:

BEGINNING at a point on the east end of the said St. Mary Road, joint corner of the St. Mary Church property, and thence thence with the St. Mary Church property line N. 1° 1' 2" E. 45.8 chains to an iron pin, Church corner; thence N. 24° 1' 4" E. 2.6 chains to an iron pin, joint corner of the Church line and Lot No. 10; thence thence with the direction line of Lots 10 and 11, S. 76° 1' 2" W. 1.8 chains to an iron pin, joint corner of Lots 10 and 11; thence thence with the direction line of Lots 10 and 11, S. 44° 6' W. 1.74 chains to an iron pin, joint corner of Lots 10, 11 and 12; thence thence with the direction line of Lots 10 and 11, S. 44° 6' W. 2.1 chains to an iron pin, joint corner of Lots 10 and 11 and the corner of the said property, with the direction line of Lots 9 and 10, S. 52° 3' 4" W. 3.3 chains to an iron pin on the west side of the said St. Mary Road; thence with the direction line of Lots 9 and 10, S. 52° 3' 4" W. 1.77 chains to the beginning corner, and thence back, as aforesaid.

This being a portion of the property known as a tract in Section 10, Block 10, page 125, Plat of the said Greenville County.



Together with all and singular the rights, members, benefits, and appendencies to the same belonging or in any way incident or appertaining, and all of the rents, dues, and profits which may now or ever be had therefrom, and including all heating, plumbing, and lighting fixtures and all other equipment or fixtures to be hereafter installed or connected thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual house furniture, be considered a part of the real estate.
