conditions), said note to be regaid with interest as the rate or rates therein specified in installments of -- Two hundred Fifty-

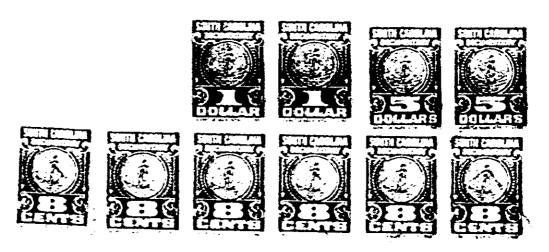
