E. Means, Jr., Residuary Trust, their interest in the following described property, to wit: ALL that piece, parcel and lot of land containing approximately 60 acres more or less with all improvements thereon in the County of Greenville, State of South Carolina lying on the Northwest side of Bramlett Road and having the following description: BEGINNING at a point in the center of Bramlett Road near the point in which a stream crosses under the said Bramlett Road and running thence N 50-30 W 1941.32 feet to a point; thence N 59-5/8 E approximately 1450 feet more or less to a point on the right of way of Southern Railway System; thence along said right of way S 61-30 E 829 feet; thence leaving said right of way and running S 53-30 E 31 feet to a point; thence S 27-40 W 200 feet to a point in the center of a Branch; thence S 41-45 E 1042 feet to a point in the center of Bramlett Road; thence with the center of Bramlett Road S 60-10 W 1209 feet to the point and place of beginning.
