MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Charlton Edward Seawright, Jr.

and Edna A. Seawright (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto W.D. Shedd

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Eleven Thousand Five Hundred and No/100 ----- DOLLARS (\$ 11,500.00),
with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid: in equal monthly installments of \$314.84 each, the first of said installments being due September 8, 1974 and a like installment due the 8th day of each month thereafter until paid in full

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot Number 4 Maple Acres, as shown on plat of said subdivision, prepared by C.O. Riddle, dated June 1953, and recorded in the RMC Office for Greenville County in Plat Book FF at Page 111; said lot having a depth of 130.9 feet on the Southern side, a depth of 125.4 feet on the Northern side, being 211.9 feet across the rear, and fronting 165.9 feet on the Northwestern side of Chastain Drive.

This is the same property conveyed to the Mortgagors by deed recorded in Deed Book 762 at Page 464 in the RMC Office for Greenville County.

This mortgage is junior in lien to that certain mortgage in favor of Aiken Loan & Security Company dated January 10, 1961, recorded in Mortgage Book 846 at Page 527 in the RMC Office for Greenville County.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
