MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

James G. Butler & Carlene M. Butler (hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Thirty y-Three

Thousand Nine Hundred Fifty and 00/100---- (\$ 33,950.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not provide a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

Seventy-Three and 19/100------(\$273.19) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not somer paid, to be due and payable .. 30 .... years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said helder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may bereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgager, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgager's account, and also in consideration of the sum of Three Dellars (53:00) to the Mortgager in hand well and truly paid by the Mortgager at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, on the southwestern side of Arundel Road, being further described as Lot 94 on a plat of Revision of Lots 94 & 95, Botany Woods, Sector II, made by Fiedmont Engineering Service, said plat being of record in the RMC Office for Greenville County in Plat Book TT at Page 192, and having the following metes and bounds. to-wit:

BEGINNING at an iron pin on the southwestern side of Arundel Road at the joint front corner of Lots 93 & 94, and running thence along the common line of said Lots S. 26-46 W. 181.5 feet to an iron pin; thence N. 60-00 W. 110.3 feet to an iron pin; thence along the line of Lot 95 N. 18-25 W. 160 feet to an iron pin on Arundel Road; thence along the southwestern side of Arundel Road S. 73-31 E. 58 feet and S. 68-03 E. 77 feet to an iron pin, the point of beginning.
