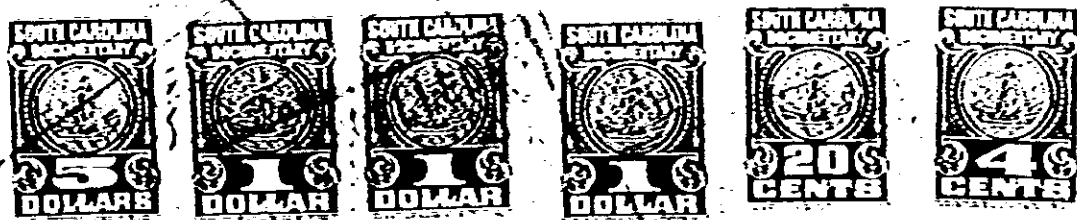

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Amy Lane, being shown as Lot No. 225 on plat of Section 6 of COLONIAL HILLS Subdivision, prepared by Piedmont Engineers and Architects, recorded in the R. M. C. Office for Greenville County in Plat Book WWW at page 13 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Amy Lane at the joint front corner of Lots Nos. 225 and 226 and running thence with Lot No. 226 S. 11-40 E. 172.2 feet to an iron pin at the joint rear corner of Lots Nos. 225 and 226; thence with Lots Nos. 243 and 244 S. 73-31 W. 100.35 feet to an iron pin at the joint rear corner of Lots Nos. 224 and 225; thence with Lot No. 224 N. 11-40 W. 180.7 feet to an iron pin on Amy Lane; thence with Amy Lane N. 78-20 E. 100 feet to the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
