TO ALL WHOM THESE PRESENTS MAY CONCERN: James A. and Helen F. Merritt

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifteen Thousand and 00/100 (\$15,000.00)----- DOLLARS

(\$ 15,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, being known and designated as Lot 11 on a Plat of property of J. W. Whitt, made by C. O. Riddle, Surveyor, February 22, 1956, and recorded in Plat Book PP, Page 99, R.M.C. Office for Greenville County and also shown on a more recent Plat of said property of Verbon C. and Alice K. Peppers, prepared by R. B. Bruce, Surveyor, and being more particularly described, according to Plat of J. W. Whitt property, to-wit:

BEGINNING at an iron pin on Sunrise Drive, at the point corners of Lots 10 and 11 and running thence with said Drive, N. 84-41 E., 130 ft. to an iron pin; thence N. 24-06 W., 228.4 ft. to an iron pin; thence S. 60-31 W., 100 ft. to an iron pin; thence S. 16-36 E., 178.6 ft. to an iron pin on Sunrise Drive being the point of beginning.
