NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No.

33, as shown on a Plat of Heritage Hills, which plat is of record in the Office of the RMC for Greenville County, S. C., in Plat Book YY at Page 187, reference to said plat being craved for a metes and bounds description thereof.

And having the following metes and bounds according to the above referenced Plat:

Beginning at an iron pin on the northern side of Butler Springs Road at the joint front corner of Lot 32 and running thence with the line of Lot 32 N 11-47 W 170.5 feet to an iron pin; thence with the line of Lot 34, S 80-15 W 144.2 feet to an iron pin on Richbourg Road; thence with Richbourg Road S 15-47 E 146.2 feet to an iron pin; thence with the curve of the intersection, the chord of which is S 57-46 E 37.2 feet to an iron pin on Butler Springs Road; thence with said road, N 80-15 W 107.2 feet to the point of beginning.
