

## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

EDWARD H. HEMBREE BUILDERS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seventy Thousand and no/100----- DOLLARS

(\$ 70,000.00----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29---- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 41 on plat of Holly Tree Plantation, Phase II, Section II, recorded in Plat Book 5D at page 48 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin at joint front corner of Lot 40 on Holly Tree Lane; thence with line of said lot, N 23-01 W 165.4 feet to an iron pin; thence N 61-57 E 63 feet to an iron pin and N 22-18 E 31.5 feet to an iron pin at rear corner of Lot 41A; thence with line of Lot 41A, S 48-59 E 161 feet to an iron pin on Holly Tree Lane; thence with said Lane, S 38-02 W 10 feet to an iron pin, S 45-05 W 72.88 feet to an iron pin, S 52-17 W 40.2 feet to an iron pin, and S 58-25 W 40.8 feet to the point of beginning.
