with interest thereon from the date hereof at the rate of 7.5 per centum per annum, said interest
to be paid on the 1st day of November 1974 and thereafter said interest
and principal sum to be paid in installments as follows: Beginning on the 1st day
of November 1974, and on the 1st day of each month thereafter the
sum of \$ 193.68 to be applied on the interest and principal of said note, said payments to continue
up to and including the 1st day of September, 2004, and the balance
of said principal sum to be due and payable on the 1st day of October, 2004,
