(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eighteen Thousand, Four Hundred Ninety and 85/100------DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwest side of Batesview Drive, being known and designated as Lot No. 17 of a subdivision known as Northside Gardens as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book S, at Page 17, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwest side of Batesview Drive at the joint front corner of Lots 16 and 17, and running thence along the common line of said lots, S. 57-09 W. 232.4 feet to an iron pin at the joint rear corner of said lots; thence N. 35-45 W. 85.1 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence along the common line of said lots, N. 57-09 E. 236.7 feet to an iron pin on the southwest side of Batesview Drive; thence along the southwest side of Batesview Drive, S. 32-51 E. 85 feet to the beginning corner; being the same conveyed to us by Andrew A. Phillips and Alice C. Phillips by deed of even date, to be recorded herewith."
