All that piece, parcel or lot of land, located, lying and being in the City of Greenville, Greenville County, State of South Carolina, on the southeastern side of Perrin Street and shown and designated as Lot 11 on plat entitled "A. A. Green Subdivision" on plat dated November 9, 1945 prepared by Pickell and Pickell and recorded in the RMC Office for Greenville County in Plat Book M at Page 145 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Perrin Street at the northwestern corner of Lot 10 and running thence with the line of Lot 10, S. 35-45 E. 189 feet to an iron pin in the line of property now or formerly of C. J. Hudson; thence along the line of property now or formerly of C. J. The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
