NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 148 of Western Hills Subdivision as shown on a plat thereof dated August 1959, by Jones & Southerland, Engineers, recorded in the RMC Office of the Greenville County Courthouse in Plat Book QQ at Pages 98 and 99, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Alice Farr Drive at the joint front corner of Lots 147 and 148, and running thence with the line of Lot 147, S. 23-30 W. 206.4 feet to an iron pin at the joint rear corner of Lots 147 and 148 on the rear line of Lot 139; thence with the rear line of Lots 139 and 138, N. 73-50 E. 133.7 feet to an iron pin at the joint rear corner of Lots 148, 138 and 137; thence with the line of Lot 137, N. 31-56 E. 115.7 feet to an iron pin on the southern side of Alice Farr Drive at the joint front corner of Lots 137 and 148; thence with the southern side of Alice Farr Drive, N. 61-19 W. 70 feet to a point, thence continuing with the southern side of Alice Farr Drive, N. 66-30 W. 50 feet to the point of beginning.
