The Morigagor further coverants to warrant and forever defend all and singular the premises unto the Morigagoe forever, from and against the Morigagor and all persons whoms over lawfully elaining the same or any part there it.

The Mortgagor covenants and agrees as follows

- 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided.
- 2. That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the juvment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein, and also any further losins, advances, readvances or credits that may be made here after to the Mortgagor by the Mortgagee, and that all sums so advanced shall bear interest at the same rate as the Mortgagee debt and shall be payable on demand of the Mortgagee, unless otherwise provided in writing.
- 3. - 5. That the Mortgagee may require the maker, co-maker or endorser of any indebtedness secured hereby to carry life insurance upon himself in a sum sufficient to pay all sums secured by this mortgage, designating the Mortgagee as beneficiary and assignee thereof, and, upon failure of the Mortgager to pay the premiums therefor, the Mortgagee may, at its option, pay said premiums, and all sums so advanced by the Mortgagee shall become a part of the mortgage debt.

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month, until the indebtedness secured hereby is paid in full, a sum equal to one twelfth of the annual taxes, public assessments and insurance premiums, as estimated by the Mortgagee, and, on the failure of the Mortgager to pay all taxes, insurance premiums and public assessments, the Mortgagee may, at its option, pay said items and charge all advances therefor to the mortgage debt.
- That he herely assigns all the rents, issues, and profits of the mortgaged premises from and after any default hereunder, and should legal proceedings be instituted pursuant to this instrument, then the Mortgagee shall have the right to have a receiver appointed of the rents, is use, and profits, who, after deducting all charges and expenses attending such proceedings and the execution of his trust as receiver, shall apply the residue of the rents issues, and profits, toward the payment of the debt secured hereby.
- 5. That, at the option of the Montgager, this montgage shall become due and payable forthwith if the Montgager shall decome world in any other person in any manner whatsoever other than by death of the Montgager.
- 9. It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured bereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and wid, otherwise to remain in full force and virtue.
