together with all rights, interests, exements, hereditaments and appartenances thereunto belonging, the reats, issues, and profits thereof and sevenues and snowne thereform, all improvements and personal property now or later attached thereto or reasonably necessary to the use thereof, including, but not limited to, ranges, refrigerators, clothes washers, clothes dryers, or carpeting purchased or financed in whole or any with hom funds, all water, water rights, and water stock pertaining thereto, and all payments at any time owing to flourower by virtue of any sale, lease, transfer, conveyance, or condemnation of any part thereof or interest therein all of which are herein called "the property"; IO HAVE AND TO HOLD the property unto the Government and its assigns forever in fee simple.

BURROWLR for himself, his helis, executors, administrators, successors and assigns WARRANTS THE TITLE to the property to the Government against all lawful claims and demands whatsoever except any lieus, encumbrances, easements, reservations, or conveyances specified hereinabove, and COVENANTS AND AGRELS as follows.

- (i) To pur promptly when due any indebtedness to the Government hereby secured and to indemnify and save harmless the Government against any loss under its insurance of payment of the note by reason of any default by Borrower. At all times when the note is held by an insured helder, Borrower shall continue to make payments on the note to the Government, as collection agent for the holder.
- (2) To pay to the Government such fees and other charges as may now or beseafter be required by regulations of the Farmers Home Idministration
- (3) If required by the Government, to make additional monthly payments of 1/12 of the estimated annual taxes, assessments, insurance premiums and other charges upon the mortgaged premium.
- (4) Thether or not the note is insured by the Government, the Government may at any time pay any other amounts required becein to be paid by Borrower and not paid by him when due, as well as any costs and expenses for the preservation, protection, or enforcement of this lien, as advances for the account of Borrower. All such advances shall bear interest at the rate borne by the note which has the highest interest rate.
- (5) All advances by the Government as described in this instrument, with interest, shall be immediately due and payable by Burrower to the Government without demand at the place designated in the latest note and shall be secured berely. No such advances by the Government shall relieve Borrower from breach of his covernant to pay. Any payment made by Florower may be applied on the note or any indebtedness to the Government secured hereby, in any order the Government determines.
