All that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being on the southwestern side of Hilltop Avenue in the County of Greenville, State of South Carolina, being known and designated as Lot No. 4 on plat entitled property of H. BEGINNING at an iron pin on the southwestern side of Hilltop Avenue at the joint front corner of Lots 3 and 4, and running thence with the joint line of said lots S. 46-10 W. 149.5 feet to an iron pin; thence S. 43-13 E. 50 feet to an iron pin at the corner of Lot 5; thence with the line of Lot 5N. 46-35 E 149.1 feet to an iron pin on the southwestern side of Hilltop Avenue, thence with Hilltop Avenue N. 43-00 E. 50 feet to the point of beginning, being the same property conveyed to the grantor herein by deed of Frank P.
