The Mortgagor coverants that it is camfully secred of the premises bereinabove described in fee simple absolute, that it has read right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all hers and encumberances except as provided between. - (2) That it will lety the improvements now existing or hereafter erected on the mortgaged property insured as may be required. from time to time by the Mortgagee against loss by fire and any other hazzrds specified by Mortgagee, in an amount not less than the morrgage debt, or in such amounts as may be required by the Morrgagee, and in companies acceptable to it, and that all such policies and rememble thereof shall be held by the Mortgagee, and have attached thereto loss grayable crauses in favor of, and in form acceptable to the Mortgagee, and that it will pay air premiums therefor when due; and that at ones hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged profiles and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the talance owing on the Mortgage debt, whether due or not

That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
