NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagee herein well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the city of GREENVILLE, and State of South Carolina, to wit: Being in Dinkin Township, and being more particularly described as follows:

BEGINNING at a point in the center of a paved road running with A.M. Stewart property line in a S. $72\frac{1}{2}$ x. 418 feet; thence running S. 21° 21' 4 feet; thence running 426 feet parallel with North Boundary to center of highway; thence running with the center of Highway, 214 feet to the beginning point and being bounded as follows; on the north and west by lands of A.M. Stewart, on the south and east by land irregular in shape, having an opportunity to be sold previously to the said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagee shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
