MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Donnye Carolyn H. Yancar

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Twenty-Three Thousand and No/100-----(\$ 23,000.00 --)

Dollars as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Eighty.

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 20 on plat of Section No. 1, DEVENGER PLACE, recorded in the RMC Office for Greenville County in PlatiBook 4-X at Page 79, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Devenger Place, joint front corner of Lots Nos. 21 and 20 and running thence with the common line of said Lots, N.48-18 W. 150 feet to an iron pin; thence N.41-42 E. 119.6 feet to an iron pin on the edge of Longstreet Drive; thence with said Drive, S.41-25 E. 126.1 feet to an iron pin at the intersection of Longstreet Drive and Devenger Place; thence with said intersection, S.08-30 W. 37.4 feet to an iron pin on Devenger Place; thence with said Devenger Place, S.41-42 W. 76.4 feet to an iron pin, the point of beginning.
