thereon situated in South Carolina, County of Greenville  
 All that piece, parcel or lot of land with buildings and improvements thereon, situate, lying and being in Greenville County, South Carolina, and being shown as Lot 68, Section 3, on a plat of a subdivision for Victor Monaghan Mills recorded in the R.M.C.
