Greenville, South Carolina hereinafter called the Mortgagor, send(s) greetings:

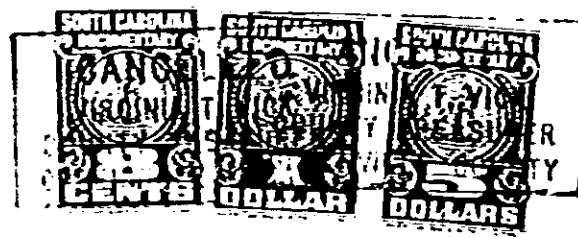
WHEREAS, the Mortgagor is well and truly indebted unto

COLLATERAL INVESTMENT COMPANY

a corporation
organized and existing under the laws of **the State of Alabama**, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are in-
corporated herein by reference, in the principal sum of **Fifteen Thousand One Hundred Fifty and**
no/100 ----- Dollars (\$ **15,150.00**), with interest from date at the rate
of **nine and one-half** per centum (**9 1/2** %) per annum until paid, said principal
and interest being payable at the office of **Collateral Investment Company**
in **Birmingham Alabama**
or at such other place as the holder of the note may designate in writing, in monthly installments of
One Hundred Thirty Two and 41/100 ----- Dollars (\$**132.41**).
commencing on the first day of **January** . **1975** , and on the first day of each month thereafter until
the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid,
shall be due and payable on the first day of **December, 1999**.

NOT KNOWN ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mort-
gagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the
receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real
estate situated in the County of **Greenville**
State of South Carolina: **on the southeastern side of Frank Street, being known as a Lot on**
Plat of WM. A. HUDSON, recorded in the R.M.C. Office for Greenville County in Plat Book
"A", at Page 265. Said lot fronts 60 feet on the southeastern side of Frank Street;
runs back to a uniform depth of 137 feet, and is 60 feet across the rear.

The mortgagors covenant and agree so long as this mortgage and the said note secured
hereby are insured under the National Housing Act, they will not execute or file for
record any instrument which imposes a restriction upon the sale or occupancy of the
mortgage property on the basis of race, color, or creed. Upon any violation of this
undertaking, the mortgagee may, at its option, declare the unpaid balance of the
mortgage immediately due and payable

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in
any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom,
and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in
connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns
forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
solute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises
are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and for-
ever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all per-
sons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at
the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal
to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior
to maturity; *provided, however*, that written notice of an intention to exercise such privilege is given at least thirty
(30) days prior to prepayment.
