conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ==Four Hundred.....

Ninety-Four and 20/100------ (5 494.20) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal bilances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable.

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and heing in the State of South Carolina, County of Greenville, being shown as Lot No. 97 on a plat of Dove Tree Subdivision, recorded in Plat Book 4X at Pages 21, 22 and 23 in the RMC Office for Greenville County, S. C., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Sugarberry Drive, joint front corner of Lots 97 and 98, and running thence with joint line of said lots N. 76-05 W. 155 feet to an iron pin; thence S. 49-18 W. 67.3 feet to an iron pin, joint rear corner of Lots 96 and 97; thence down joint line of said lots S. 43-52 E. 187.4 feet to a point on the northwesterly side of Sugarberry Drive; thence around Sugarberry Drive, the following courses and distances, to-wit: N. 56-48 E. 34.5 feet; N. 28-08 E. 45.1 feet; N. 15 E. 50.1 feet and N. 13-55 E. 35.3 feet to point of beginning.
