of Greenville, South Carolina , hereinafter called the Mortgagor, is indebted to XXX Administrator of Veterans' Affairs, an Officer of the United States of America, and his successors in such office, as such, and his or their assigns, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of m of EIGHT THOUSAND FOUR HUNDRED AND NO/100 Dollars (\$ 8,400.00), with interest from date at the rate of SIX %) per annum until paid, said principal and interest being payable per centum (6 at the office of the Loan Guaranty Officer, Veterans Administration Regional Office, at Columbia, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Dollars SEVENTY AND 88/100 day of 19 74), commencing on the 1st December (\$ 70.88 and continuing on the day of each month thereafter until the principal and interest lst are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the day of February 1st

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, and unto his successors in such office, as such, and his or their assigns, the following described property, to-wit:

All that property situated in the County of Greenville, State of South Carolina on the northern side of Yown Road and being known and designated as Lot No. 8 on plat of property of Talmer Cordell recorded in the R. M. C. Office for Greenville County in Plat Book "PP", at Page 175, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Yown Road at the joint front corner of Lots 8 and 9 and running thence along the north side of said Road S. 85-10 W. 80.5 feet to an iron pin; thence N. 11-40 W. 285.8 feet to an iron pin; thence N, 86-19 E. 80.3 feet to an iron pin; thence along the line of Lot No. 9 S. 11-45 E. 283.1 feet to the point of beginning.

This is the same property conveyed to the Administrator by Master's Deed dated December 29, 1966, and recorded December 29, 1966, in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 811, at Page 214, and being the identical property conveyed to the mortgagor herein by deed of the same date from the Administrator of Veterans Affairs to be recorded simultaneously with this mortgage.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
