NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand welt and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE consisting of three (3)

units as shown on a plat of the Horizontal Property Regime pertaining to Centre West Shooping Center as recorded in Deed Book 1001 at page 64 and being known as Units B-8, B-9 & B-10.

Units B-3, B-9, and B-10 are subject to a first mortgage held by First Federal Savings and Loan Association in the original amount of \$90,000.00 dated July 29, 1974 and being of record in the RMC Office for Greenville County.

The mortgagee hereby agrees that this mortgage and that note secured hereby may be satisfied in full by a conveyance of the subject property subject to the aforesaid mortgage.
