

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

One Hundred

Twenty-nine and 63/100 ----- (§ 129.63)) Dollars each on the first day of each month hereafter in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest computed monthly on inpuid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 29 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzazee, or any stipulations set out in this provizage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings, and

WHEREAS, the Mortzagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgager's account for the payment of taxes insurance premiums, repairs, or for any other purpose,

That the Mortgagor, in consideration of said delt and to secure the payment thereof and any further sinus which may be a branced by the Mortgagor's incomment, and also in consideration of the sum of Three Dollars (S100) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, but and released, and by these presents dies grant, burgain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate.

All that certain piece, parcel, or kt of lind with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, being known and designated as lot 30, Monaview Subdivision, plat of which is recorded in the R. M. C. Office for Creenville County in Plat Book 4N at Page 52, and according to said plat, having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Monaview Court, joint front corner of Lots 31 and 30 and running thence with the joint line of said lots, N 65-24 E 146.4 feet to an iron pin at the joint rear corner of Lots 30, 31, 32 and 33 and running thence with the joint line of Lots 30 and 33, N 8-23 E 166.5 feet to an iron pin in rear line of Lot 20; thence S 84-12 W 20 feet to an iron pin in the rear of Lot 21 and running thence with the joint line of Lots 29 and 30, S 28-48 E 228.95 feet to an iron pin on Monaview Court; thence with Monaview Court, S 42-54 E 31.45 feet to an iron pin, the point of beginning.
