conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

Fifty One and 75/100------ (§251.75) Dollars each on the first day of each month bereafter in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment if not sooner paid, to be due and payable 30 years after date, and

WHEREAS said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and in paid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzazee, or any stipulations set out in this posterize, the whole anount due the reunder shall at the option of the holder thereof, become immediately due and payable and said helder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel or let of land with all improvements thereon or hereafter to be constructed thereon, situate, bying and leave in the State of South Carolina, Genety of Greenville, city of Mauldin, being known and designated as Lot No. 21 as shown on plat of BROOKSIDE, Sec. II, as shown on plat recorded in plat book 5 D at page 24 of the RMC Office for Greenville County, S. C., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Brooks Drive, the joint front corner of Lots 20 and 21, and running thence with the joint line of said lots, N. 30-58 W. 163.3 feet to an iron pin, rear corner of Lot 25; thence with the rear line of lot 25, N. 59-06 E. 100 feet to an iron pin, joint rear corner of Lots 21 and 22; thence, with the joint line of said lots, S. 30-54 E. 159.3 feet to an iron pin on the northwest side of Brooks Drive; thence with the northwest side of said street, S. 56-47 W. 100 feet to the point of BEGINNING.
