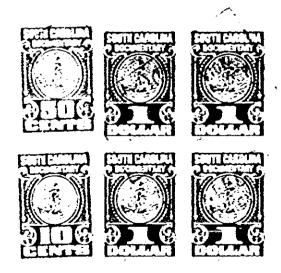

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots Nos. 32 and 33, Cak Hill Drive, as shown on plat of Shady Acres, which plat is of record in the RMC Office for Greenville County, S. C., in Plat Book CCO, pages 76 and 77, and having, according to said plat, the following metes and bounds, to-wit:

The total perimeter area of the two combined lots being as follows:

Beginning at a point on the western side of Cak Hill Drive, joint front corner of Lots 31 and 32; thence running with the joint line of said lots N. 87-94 W. 100 feet to a point; thence running with joint rear line of Lots 32 and 33 N. 02-56 E. 170 feet to a point at joint rear corner of Lots 33 and 34; thence running with the joint line of said lots S. 87-04 E. 100 feet to a point on the western side of Oak Hill Drive; thence running with the western side of Oak Hill Drive S. 02-56 W. 170 feet to point of beginning.
