All that certain piece, parcel, or lot of find with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, on the southern side of Mylon Ray Hopkins Court, being known and designated as Lot No. 179 on plat of Forrester Woods, Section IV, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book 4-R, at page 68, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Mylon Ray Hopkins Court, joint front corner of Lots 179 and 182 and running thence along the common line of said lots S. 37-0 W. 141.8 feet to an iron pin, joint rear corner of Lots 179, 182, 180 and 181; thence turning and running along the common line of Lots 179 and 180, N. 70-0 W. 100 feet to an iron pin; thence turning and running N. 27-04 E. 170 feet to an iron pin, joint corner of Lots 179 and 152; thence turning and running along Mylon Ray Hopkins Court, S. 54-40 E. 125 feet to the point of beginning.
