WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-One Thousand Five Hundred and no/100-----DOLLARS

(\$21,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

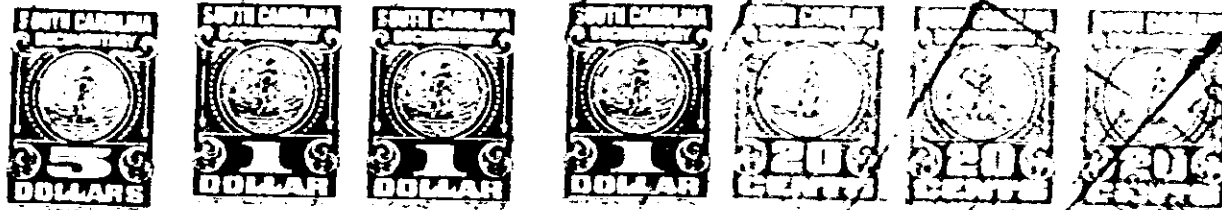

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 167, Section III, Lake Forest Subdivision on plat prepared by Piedmont Engineering Service, dated August, 1954, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book GG at Page 77 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Malvern Place, joint front corner of Lots No. 166 and 167 as shown on the aforementioned plat and running thence along and with the joint property line of said two lots N 52-24 W 204.3 feet to an iron pin; thence S 40-03 W 154.5 feet to an iron pin at the joint rear corner of Lots Nos. 167 and 168 as shown on said plat; thence running along and with the joint property line of said last two mentioned lots, S 46-01 E 164.1 feet to an iron pin on the northwestern side of Malvern Place; thence running along and with the northwestern side of Malvern Place N 52-39 E 148.8 feet to an iron pin; thence continuing along Malvern Place, N 55-57 E 35 feet to the beginning point. For a more particular description see the aforementioned plat.

This being identical property conveyed to Gordon Laverne Lake and Marilyn H. Lake by deed recorded in said R. M. C. Office in Deed Book 731 at Page 148.
