All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville, Chick Springs</u>

Township, located about one-half mile east from Chick Springs on the south side of Alexander Drive, bounded by lands of Southern Bleachery and Prints Works and lands now or formerly owned by G. D. Collier and possibly other and having the following courses and distances:
