MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

R. C. JONES and ANDER V. JONES

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Thirty-Nine

Thousand One Hundred Fifty and Mc/100----- (\$ 39,150.00...)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note = 0000 not include a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Three Hundred

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, being known and designated as Lot Mc. 77 as shown on plat of FURLETT ESTATES, prepared by Dalton & Neves Cc., Engineers, lated February, 1971, revised December, 1973, which plat is of record in the R.M.C. Office for Greenville County, S. C., in Flat Fook 4-X, at page 60, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Libby Lane at the joint front corner of Lots 7ℓ and 77, and running thence with line of Lot 7ℓ, N. 12-30 W. 134.81 feet to an iron pin at joint rear corner of Lot 7ℓ and 7ℓ; thence with line of Lot 7ℓ, N. 77-52 E. 150 feet to an iron pin on the western side of (1) Mill Foad; thence with western side of Old Mill Road, S. 12-00 E. 110.0 feet to an iron pin; thence continuing with line of Old Mill Foad, S. 31-51 W. 35.2 feet to an iron pin on the northern side of Libby Lane; thence with northern side of Libby Lane, S. 78-25 W. 125 feet to point of beginning.
