NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville, all that certain piece, parcel or lot of land, situate, lying and being on the southerly side of Randy Drive, near Taylors, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 10 according to plat of Section 2, Edwards Forest, prepared by Dalton & Neves, Engineers, March 1971, and having the according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the southerly side of Randy Drive at the joint front corner of Lots 10 and 11, and running thence S. 33-11 E. 100 feet to an iron pin at the joint rear corner of said lots; thence N. 36-45 E. 100 feet to an iron pin at the joint rear corner of lots 9 and 10; thence along the joint line of said lots N. 33-11 W. 100 feet to an iron pin on the southerly side of Randy Drive; thence along said line drive S. 36-45 W. 100 feet to an iron pin, the point of beginning.

This conveyance is made subject to any and all existing reservations, easements, right of way, zoning ordinances and restrictions or protective covenants that may appear of record, on the recorded plat(s) or on the premises.

TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagee, its successors and assigns forever.

If Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, liens, assessments, obligations, prior encumbrances, and any charges whatsoever against the above described real estate as they become due. Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to Mortgagee in Mortgagee's favor.

If Mortgagor fails to make any of the above mentioned payments or fails to maintain satisfactory insurance, Mortgagee may, but is not obligated to, make such payments or effect insurance in Mortgagee's own name, and such payments and expenditures for insurance shall bear interest at the highest lawful rate if not prohibited by law, shall be a lien hereunder on the above described real estate, and may be enforced and collected in the same manner as the other debt hereby secured.

Upon any default, all obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.
