For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, Blue Ridge PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Byron F. Stone and Sandra L. Stone & Ruth G. Stone to it, on June 2, 1970, recorded in Mortgage Book 1156, page 543, public records of GREENVILLE County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property: ALL that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being shown on plat of survey of Byron F. Stone, dated 4-30-75, prepared by Aaron M. Thompson, Registered Land Surveyor, and having according to said plat, the following metes and bounds, to-wit: BEGINNING at a nail and cap in the center of Sullivan Road, which nail and cap is located approximately 1,816 ft. Southeast of Georgia Road, and running thence with property, now or formerly, of Ansel Kellett, N. 53-59 E., 375.5 ft. to an iron pin; thence with property, now or formerly of B.F. Stone S. 36-01 E., 120 ft. to an iron pin; thence continuing with line of said Stone property, S. 53-59 W., 393.28 ft. to a nail and cap in center of Sullivan Road; thence with the center line of Sullivan Road, N. 23-03 W., 60 ft. to a nail and cap; thence continuing with the center line of Sullivan Road, N. 32-03 W., 61.63 ft. to the beginning corner.
