ALL those certain pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville being known and designated as a portion of Lots Nos. 25 and 26 as shown on a plat of property of James M. Edwards recorded in the RMC Office for Greenville County in Plat Book EE at page 60 and also being shown as a portion of the property identified on a plat prepared by Campbell and Clarkson, Surveyors dated July 15, 1971 identified as a portion of Lots 25 and 26 of James M. Edwards Property and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Cherokee Drive located approximately S. 48-42 E. 225.9 feet from the intersection of Cherokee Drive and Wade Hampton Boulevard and running thence S. 43-00 W. 196.7 feet to an iron pin in the line of Lot No. 24; running thence with the line of Lots No. 24 N. 47-00 W. 15 feet to a point; running thence N. 43-00 E. 196.7 feet, more or less, to a point on Cherokee Drive and running thence with the southwestern side of Cherokee Drive S. 48-42 E. 15 feet to te point of BEGINNING.

Except however, it is specifically understood and agreed that the mortgage of First Piedmont Bank and Trust Company covers an easement for ingress and egress along said 15 foot strip hereinabove described.
