

(6) That if there is a default in any of the terms, conditions or covenants of the mortgage secured hereby, then at the option of the Mortgagee, it may thereupon by the Mortgagee, its Mortgagee, or all or any of its heirs, assigns and personal representatives, cause the mortgage to be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee be in any way prevented from enforcing this mortgage or the title to the premises described herein, or should the debt secured hereby in any way be placed in the hands of any other person at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall be recoverable, to be paid immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected thereunder.

Whenever used the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
